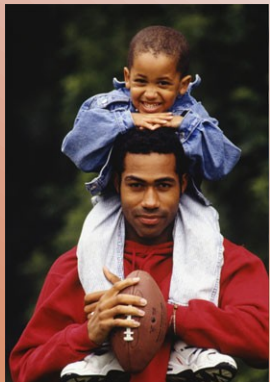
# What is a Serving Team?
